

Consent Form for participation in a user study for analyzing privacy risks perception

Thanks for participating in a user study by Insa Lyon and Chalmers University of Technology.

The purpose of this study is to evaluate the perception of privacy risks through a use-case scenario.

What will be discussed in the study?

In this user study involving you and around 20 other participants, we will discuss:

- your perception of privacy risks
- your perception of data protection regulations
- your perception on the link between the two

We ask to answer the questions and contribute to the discussion from the perspective and **NOT to reveal any sensitive personal data** about yourself.

What data will be collect, on what legal grounds and for what purposes? Who will process your data?

Data will be collected based on the legal basis of performing a task carried out in the public interest (Art. 6 (1) (e) GDPR).

Insa Lyon will as the data controller request demographic data about:

- Your age group
- Your gender

All requested information can be optionally given or left out in the form.

Moreover, notes will be taken, and an interview may be audio-recorded.

All data will be used for research purposes only. The descriptions, comments and findings may be used to help to elicit end user requirements to be reported in research papers.

In addition, a list matching your name with a pseudonym will be created for the purpose of pseudonymisation of all data collected for this focus group.

How will your data be processed?

All your data will be kept confidential and stored safely, transcribed, pseudonymised as soon as possible and only kept as long as the purpose of processing requires, or as long as required by law.

The list matching your names to pseudonyms will be kept separately from all other collected data at a secure place.

Data processing and handling will be done by Insa Lyon in cooperation with Chalmers University of Technology and in compliance with the EU General Data Protection Regulation (GDPR).

At no time, your name or any other information that may directly identify you will be used when reporting the results. **No personally identifying information about you or any other (real) person should be revealed by you in the context of the interview.** If any sensitive personally identifying data is stated by you during the interviews, we will interrupt the interview and ask you to stop

revealing such information, and we will delete the respective recording and not take any notes on that part.

Voluntary Participation & Your Rights:

Submission of the questionnaires is **completely voluntary**. You are free to leave or end the test at any point without explanations. You can also exercise your data subject rights to access, rectification, deletion or blocking of your data according to the GDPR without any costs – data deletion is however only possible up to the time that the results of the study analyses will be published in anonymised form.

The study is designed to elicit requirements and not to evaluate your knowledge. **There are no wrong or right answers to the questions being asked.**
